- Well-known journal titles (such as HZ, JRS, JHS, etc.) can be abbreviated. However, use journal abbreviations only if you can resolve them. Journals are generally abbreviated according to the directory of **L'année philologique**.
- Abbreviations for important series and editions can be found in **Kleiner Pauly**, vol. 1 or in **New Pauly**, vol. 3.
- You can abbreviate first names of authors and editors; however, the first name allows you to distinguish between authors with the same name and the same first letter of the first name (e.g., Averil and Alan Cameron); moreover, you then know the gender of the author ("He means/She means...").
- A full stop at the end of the bibliographical entry is obligatory.
- "f." = the following page; but no "ff." for two or more following pages, but then the exact page reference ("pp. 25-28").
- Make sure that you quote consistently!

<sup>1</sup> For modern authors, use short titles; preferably [author]/[year of publication]/[page number] ("Meier 1998, p. 68"); it is also possible to use a short title consisting of author and a core term from the title ("Meier, Aristokraten, p. 68"), which are broken down in the bibliography: Meier, Aristokraten = Meier, Mischa: Aristokraten und Damoden. Untersuchungen zur inneren Entwicklung Spartas im 7. Jahrhundert v. Chr. und zur politischen Funktion der Dichtung des Tyrtaios, Stuttgart 1998.
